#### **NEW BUSINESS:**

#### **CHIPS**

The amounts authorized for the CHIPS, PAVE NY and EWR reimbursement programs may be subject to a reduction of up to 20 percent, contingent upon revenue impacts directly related to the Novel Coronavirus (COVID-19). The office was informed by the NYSDOT Regional CHIPS Representative's Office to budget without the PAVE NY and EWR for next budget, and to reduce the CHIPS revenue by 20% in preparation for not receiving it in the following year.

### COURT DRIVER'S DIVERSION PROGRAM

**Resolution** #4 The Village of Savona Board of Trustees resolved to accept the proposed Intermunicipal Cooperation Agreement Pursuant to Article 5-G of the General Municipal Law. The board authorizes the Mayor of Savona to sign the agreement.

### In summary:

- 1. The Village of Savona shall receive 30 percent of net monies collected from any successful completion of the Traffic Diversion Program originating from its geographical limits.
  - a. ) Any such payments to the Village of Savona shall be made by the Steuben County Finance Department on a quarterly (every three (3) months) basis.
  - b. ) For any traffic ticket that is not disposed of through successful completion of the Traffic Diversion Program the Village of Savona shall be entitled to only those fees and surcharges they are entitled to under applicable New York State law.
  - c. ) The parties agree that the service charge shall be subject to periodic review and can be changed at any time by the Steuben County Public Safety Committee upon the recommendation of the District Attorney and the Commissioner of Finance.
